**EG-Cairo: ENPI — supply of communication hardware and software for enhancing road safety in Egypt through the reform of road safety planning and operations twinning project**

**Supply procurement notice**

1. **Publication reference:**

The Programme Administration Office for the Support to the Association Agreement Programme (PAO-SAAP), on behalf of the Egyptian Ministry of International Cooperation, Cairo, EGYPT.

**Contract specifications**

6. **Description of the contract:**  
The development of a national accident management system intended to be built as a new system for both investigating and analysing road accident data as a shared 'space' for all parties responding to different kinds of road accidents, such as medical rescue services, police forces, fire brigades, hospital personnel and road administration. The contract will be concluded for the supply of communication hardware and software and satellite images and digital maps.
7. **Number and titles of lots:**  
The contract is divided into 3 lots:
  - lot 1: communication software,
  - lot 2: communication hardware,
  - lot 3: satellite images and digital maps.

**Terms of participation**

8. **Eligibility and rules of origin:**  
Participation is open to all legal persons participating either individually or in a grouping (consortium) of tenderers which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see item 22 below). All goods supplied under this contract must originate in 1 or more of these countries. Participation is also open to international organisations. Participation of natural persons is directly governed by the specific instruments applicable to the programme under which the contract is financed.
9. **Grounds for exclusion:**

Tenderers must submit a signed declaration, included in the tender form for a supply contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the 'Practical Guide to contract procedures for EU external actions'.

10. **Number of tenders:**

Tenderers may submit only 1 tender per lot. Tenders for parts of a lot will not be considered. Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than 1 lot. Tenderers may not submit a tender for a variant solution in addition to their tender for the supplies required in the tender dossier.

11. **Tender guarantee:**

Tenderers must provide a tender guarantee of 1 500 EUR for lot 1, 1 200 EUR for lot 2 and 1 300 EUR for lot 3 when submitting their tender. This guarantee will be released to unsuccessful tenderers once the tender procedure has been completed and to the successful tenderer(s) upon signature of the contract by all parties. This guarantee will be called upon if the tenderer does not fulfil all obligations stated in its tender.

12. **Performance guarantee:**

The successful tenderer will be asked to provide a performance guarantee of 10 % of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the contracting authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.

13. **Information meeting and/or site visit:**

An optional information meeting and a site visit will be held on 19.5.2011, 1 Mahmoud Al Meligy St., Nasr City, Cairo, EGYPT.

14. **Tender validity:**

Tenders must remain valid for a period of 90 days after the deadline for submission of tenders.

15. **Period of implementation of tasks:**

The period of implementation of tasks is 90 calendar days from the signature of the contract until the provisional acceptance.

**Selection and award criteria**

16. **Selection criteria:**

The following selection criteria will be applied to tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

1) Economic and financial capacity of tenderer (based on i.a. item 3 of the tender form for a supply contract). In the case of the tenderer being a public body, equivalent information should be provided:

- the average annual turnover of the tenderer must exceed 115 000 EUR, and
- the averages of cash and cash equivalents at the beginning and end of the last 3 years (2007, 2008, 2009) are positive.

2) Professional capacity of tenderer (based on i.a. items 4 and 5 of the tender form for a supply contract):

- at least 10 staff currently work for the tenderer in fields related to this contract,
- the tenderer has a professional certification to this contract,
- at least 20 % of all staff working for the tenderer this year in the fields related to this contract are permanent.

3) Technical capacity of tenderer (based on i.a. items 5 and 6 of the tender form for a supply contract):

- the tenderer has worked successfully on at least 3 projects with budgets of at least 400 000 EUR in fields related to this contract in the past 3 years.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. Some examples of when it may not be considered appropriate by the contracting authority are when the tenderers rely in majority on the capacities of other entities or when they rely on key criteria. If the tenderer relies on other entities it must prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality, as the economic operator. Furthermore, the data for this third entity for the relevant selection criterion should be included in the tender in a separate document. Proof of the capacity will also have to be furnished when requested by the contracting authority.

17. **Award criteria:**

Price (or, if appropriate after derogation, the best value for money which is a combination of quality/price).
