The company will be entrusted with the surveillance and protection of the premises of the EU Delegation in Swaziland, the EU compound and houses of the expatriate staff of the Delegation. The scope of the services includes, but is not limited to, the following:

- the surveillance and patrolling of the premises with a view to avoiding any intrusion and attack on persons and their belongings,
- the control of access to the premises by visitors,

- the communication between the premises by means of a VHF radio network linking all the premises to a central operations centre to be manned by operators provided by the company,
- the immediate intervention by use of rapid response or back-up unit to any of the premises in the event of an incident,
- other security services such as installation of intruder alarms.
